- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: AT NIGHT
- Licensed practical nurse, days and times: AT NIGHT
- Certified nursing assistant or long term care workers, days and times: YES AT NIGHT TOO
- Awake staff at night
- Other: ON CALL CAREGIVERS
