Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

Assistance ranges from, monitoring, cueing, cutting food to small pieces to total assistance

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Includes transferring on-off the toilet, changing briefs, peri-care

3. WALKING

If needed, the home may provide assistance with walking as follows:

Assistance is provided by helping residents to stand, support and total assistance while walking

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Employees are trained and well experienced in sit to stand hooyer lift, resident are also assisted when moving between surfaces such as wheelchair, bed, chair or standing position

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Assistance is provided in bed mobility in repositioning the resident (prn)

6. PERSONAL HYGIENE

Medication Services
