Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

We can assist with cueing, guidance of hands or full assisted feeding if necessary

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Cueing, stand-by, hands-on, assistance off and onto the toilet. Assistance with personal hygiene tasks.

3. WALKING

If needed, the home may provide assistance with walking as follows:

Cueing, stand-by assistance.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Cueing, stand-by assistance, use of sit-to-stand life as needed.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Cueing, pillowing, using draw sheets for bed repositioning as needed.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Cueing, stand-by or hands-on assistance with shaving, curling hair, peri care or even hair cuts.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Cueing, hands-on assistance with total assist.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

We help with cueing or stand-by assistance as well as full assist as well as bed baths and lift transfers into the shower.

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

We help with all ADL's and provide comfort care for those in the final stages of life.

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. Medicines are kept in a locked cupboard and administered by delegated caregivers.

Staffing

(WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

Medicaid
