## Personal Care

If needed, the home may provide assistance with walking as follows:

**All forms of assistance--standby, using assistive device transferring**

### 4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**Standby, active, turning protocol per doctors orders**

### 5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

### 6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

## Medication Services
