Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

Cuing the resident to eat and/or feeding the resident if needed.

Providing adequate and nutritious food and snacks.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Assisting the residents with toileting needs.

Provide clean linen and sanitary pads

Changing briefs as needed.

3. WALKING

If needed, the home may provide assistance with walking as follows:

Assist residents with walking.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Mechanical transfers with hoist lift or stand lift is provided.

Assistance with any form of transfer will be provided within the home.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Assistance with positioning in bed or wheelchair.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Personal grooming such as brushing teeth, combing hair, skin care will be provided

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Assistance or total care with dressing.

Giving the residents the right to choose their clothes.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Assistance with showers or bedbaths will be provided.

The home will provide shower chairs.

Basic personal care products will be provided. (Body wash, Shampoo, toothpaste, lotions).

Medication Services

We use ReadyMeds pharmacy that provides all the medications pre-packed.

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

Wound Care, Catheter, diabetes care (Insulin injections), tube feeding.

The home has the ability to provide the following skilled nursing services by delegation:

Insulin Injections, Catheter, tube feeding.

The home has a Nurse visiting the residents 3-4 days a week.

Staffing

(WAC 388-76-10040)

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
