Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

We encourage independence and also provide eating assistance, which includes monitoring and total assistance.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

We encourage independence and also provide toileting assistance, which includes monitoring and total assistance.

3. WALKING

If needed, the home may provide assistance with walking as follows:

We encourage independence on case by case basis and also provide walking assistance, which includes monitoring to a one or two person and assist.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

We encourage independence and also provide transfer assistance, which includes cueing and monitoring to a one or two person assist.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

We encourage independence and also provide assistance with positioning from cuing and monitoring to a one or two person assist.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

We encourage independence and also provide assistance with personal hygiene which includes monitoring, cueing, set up and total assistance.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

We encourage independence and also provide assistance with dressing which includes monitoring, cueing, set up and total assistance.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

We encourage independence and also provide assistance with bathing which includes monitoring, cueing, set up and total assistance.

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

At Ace Haven, we provide 24hr personalized care, to facilitate the highest level of independence possible for each resident, taking into consideration the residents's mental and physical capabilities

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. Ace Haven AFH provides monitoring oversight for use of all medications and assist resident to Self Administer medications. in compliance with the Washington state medication Assistance laws. and as ordered by physician.

Ace Haven Medication Management works in compliance with the Washington state medication Assistance laws. and as ordered by physician.

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

When it is determined that the resident can no longer "Self Administer" their own medicines, Nurse Delegation will be set up to facilitate Medication administration as required by Washington State Laws.

The home has the ability to provide the following skilled nursing services by delegation:

Administration of prescribed Medication, blood glucose testing, Insulin shots, simple wound care, colostomy care and more.

(WAC 388-76-10040)

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
