Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

We provide nutritious meal and assign individual caregivers to help with eating for those who need one.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Our facility is designed complying with state disability regulations. We assign individual caregivers to help with toileting.

3. WALKING

If needed, the home may provide assistance with walking as follows:

Our facility is designed complying with state disability regulations. We assign individual caregivers to help with walking. Our staff will conduct assisted walking routines at least once a day.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Our facility is designed complying with state disability regulations. We assign individual caregivers to help with transferring into and out of bedding, chair or otherwise as needed.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Our facility is designed complying with state disability regulations. We assign individual caregivers to help with positioning into and out of bedding, chair or otherwise as needed.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Our facility is designed complying with state disability regulations. We assign individual caregivers to help with personal hygiene like brushing, bathing, or other personal hygiene related activities as need.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Our facility is designed complying with state disability regulations. We assign individual caregivers to help with dressing or undressing.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Our facility is designed complying with state disability regulations. We assign individual caregivers to help with bathing, get in and out of a bathing facility.

In addition to above stated, our facility will provide laundry services to residents personal items.

Medication Services

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

We have skilled Nursing assistant services. We also plan to contract a nurse to provide a nurse delegation.

The home has the ability to provide the following skilled nursing services by delegation:

We can provide skilled nursing services including but not limited to medication, insulin injection, dressing change, minor physical activities, etc.

Staffing

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
