WAC 388-76-10845 Emergency drinking water supply. The adult family home must have an on-site emergency supply of drinking water that:

(2) Is at least three gallons for the home's licensed capacity, every household member, and caregiving staff;

This requirement was not met as evidenced by:

Based on observation, interview and record review, the adult family home (AFH) failed to ensure three gallons of water were available as emergency drinking water supplies for five current residents and one caregiving staff. This placed Resident #1, #2, #3, #4, #5, and one caregiving staff at risk for dehydration and complications in an emergency event.

Findings included...

On 04/10/19 at 10:00 AM during observation tour of the AFH with Staff A, Entity Representative/ Resident Manager, showed four gallons of water in a plastic jar and twenty-four 500 milliliters (ml.) of water in small plastic containers (3.17 gallons) were found in the AFH garage. This was a total of 7.17 gallons of water. The AFH needed at least eight more gallons of emergency drinking water for five current residents, Resident #1, #2, #3, #4, #5, and one caregiving staff who resided at the home.

In an interview on 04/10/19 at 10:25 AM, Staff A stated, "I do not know what is the requirement for water supplies for every resident."

(2) A documented negative result from one skin or blood test in the previous twelve months.

This requirement was not met as evidenced by:

Based on interview and record review, the adult family home (AFH) failed to ensure a one step Tuberculosis (TB) skin testing was completed within three days of hire for one of three sampled staff (Staff B, Caregiver) due to a previous negative one step in the last twelve months. This placed Resident #1, #2, #3, #4 and #5 at risk for exposure and contracting the communicable disease.

On 04/10/19 at 11:00 AM on record review showed, the AFH hired Staff B to the AFH on 01/31/19. Staff B completed a previous one Step TB skin testing on 06/08/18 and was read on 06/11/18 with a negative result. Further review showed a one step TB skin test was not completed within three days of Staff B's hire to the AFH on 01/31/19 due to the previous one step TB testing completed in the previous twelve months.

In an interview on 04/10/19 at 11:30 AM, Staff B stated that he did not complete a one step TB skin testing within three days of hire to the home.
