Personal Care

If needed, the home may provide assistance with transferring as follows:

1 or 2 person transfer, also a hoist

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

assist with positioning in and out of areas or elevation

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Reminders of personal hygiene or assisting with tasks

- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
