### Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

#### 1. EATING

If needed, the home may provide assistance with eating as follows:

**We can provide one on one feeding assistance, set-up assist, PEG Tube, Modified textured diet**

#### 2. TOILETING

If needed, the home may provide assistance with toileting as follows:

**Incontinent care of bowel and bladder, catheter care with delegation for non-licensed professional staff, bowel/bladder training.**

#### 3. WALKING

If needed, the home may provide assistance with walking as follows:

**Stand-by assist, contact-guard assist, assistance with medical devices, walker/ wheelchair.**

#### 4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**1-2 person assist with transfer, guiding of limbs, pivot assist**

#### 5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**1-2 person assist with positioning, change of position during the night, shifting on recliner, wheelchair, chair.**

#### 6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**Personal hygiene provided, incontinent care of bowel/ bladder, 1-2 person assist**

#### 7. DRESSING

If needed, the home may provide assistance with dressing as follows:

**Minimal- total dependent assistance with dressing**

#### 8. BATHING

If needed, the home may provide assistance with bathing as follows:

**Minimal assistance- total dependent. We provide daily sponge bath to our residents (in between showers)**

### Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. **Skilled Nursing Services and Nurse Delegation**

**Staffing**
