Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

cuing, set up, cut up and feeding assistance as needed.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

cuing, set up, and physical assist with undergarment and peri care as needed.

3. WALKING

If needed, the home may provide assistance with walking as follows:

cuing, stand by, guarding, escorting via wheel chair or other assisted devices as care planned

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

cuing, stand by, guarding, physical assist or assist with mechanical lift device or other transfer device as care planned.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

cuing, stand by, physical assist or air mattress as needed and care planned.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

cuing, set up, or physical assist as care planned

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

cuing, set up, or physical assist as care planned.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

cuing, set up, stand by or physical assist as care planned.

additional needs will be assessed and care planned per RN assessment and agreement with resident and POA

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

Medication set up, cuing, and assistance per care plan. Staff to be delegated per WAC and RN oversight. Medications may include, oral, topical, SQ injection or given via G-tube.

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

Wound care determined by RN, home dialysis, G-tube feedings, and home health PT/OT with outside agencies.

The home has the ability to provide the following skilled nursing services by delegation:

wound care, medication management, and diabetic care, G-tube feedings

Staffing

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: At all times
- Licensed practical nurse, days and times: _____
- Certified nursing assistant or long term care workers, days and times: At all times
- Awake staff at night
- Other: **Staff on call at night for any needed services, care plan to determine night time care needs.**
