Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

We provide from cuing and monitoring to total assistance.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

We provide from cuing and monitoring to total assistance.

3. WALKING

If needed, the home may provide assistance with walking as follows:

We provide from cuing and monitoring to total assistance of one person.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

We provide from cuing and monitoring to total assistance of one person.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

We provide from cuing and monitoring to total assistance of one person.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

We provide from cuing and monitoring to total assistance of one person.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

We provide from cuing and monitoring to total assistance of one person.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

We provide from cuing and monitoring to total assistance of one person.

Medication Services

Skilled Nursing Services and Nurse Delegation

(WAC 388-76-10405)

Staffing

The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: only as needed
- Licensed practical nurse, days and times: _____
- Certified nursing assistant or long term care workers, days and times: 1 caregiver per 24 hour shifts
- Awake staff at night
