Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

one-on-one feeding assistance

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Help client in hygiene care including, incontinence care, bathroom usage

3. WALKING

If needed, the home may provide assistance with walking as follows:

Staff will help clients in all recommended physical strength building, including help with walking

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

staff will help client with safe transfer from bed to wheelchair, from wheelchair to couch etc

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

staff will be available to reposition client as needed, and recommended by primary care provider, and client's assessment

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Staff will help client with all aspects of personal hygiene

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

staff will help client with dressing as needed, and as requested by the client.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

staff will help with bathing, as needed and recommended

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

staff will help in all ADLS as requested by client, recommended by primary care provide, and the care plan

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. Staffing

The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: As needed
- Licensed practical nurse, days and times: _____
- Certified nursing assistant or long term care workers, days and times: 24 hours a day, 7 days a week
- Awake staff at night
- Other: **this home has no awake staff at night. however, staff will be available 24/7 in the home**
