This requirement was not met as evidenced by:

Based on record review and interview, the adult family home (AFH) failed to ensure that one of three caregivers (Caregiver C) had a valid Washington state name and date of birth background check (BGC). This failure placed all the residents (Residents 1, 2, 3, 4 and 5) at risk of receiving care and services from someone who may have a disqualifying criminal background.

Findings included...

During an interview on 09/24/2021 at 10:44 AM, Resident Manager (RM), stated that Caregiver C (CG C) works on-call shifts at the AFH.

Record review on 09/24/2021 showed CG C had an expired BGC. Caregiver C's BGC expired on 05/16/2021.

During an interview on 09/24/2021 at 3:30 PM, RM, stated that there was no valid BGC on file for CG C. The RM stated that she would obtain a valid BGC for CG C.

This requirement was not met as evidenced by:

Based on observation and interview, the adult family home (AFH) failed to maintain the home in good repair. This failure placed five of five residents (Residents 1, 2, 3, 4 and 5) at risk of a decreased quality of life.

Finding included...

Observation on 09/24/2021 at 9:50 AM, showed the sink vanity in the upstairs bathroom was missing one of its decorative cabinet drawers. The missing cabinet drawer left a hole in the front of the sink vanity.

During an interview on 09/24/2021 at 9:53 AM, Resident Manager (RM), stated that the AFH still had the missing decorative cabinet drawer piece. The RM stated that the cabinet drawer had broken off. The RM stated that she would fix the broken decorative cabinet drawer.

Observation on 09/24/2021 at 10:20 AM, showed one of the kitchen cabinet drawers was broken and missing. During an interview on 09/24/2021 at 10:23 AM, RM, stated that the missing cabinet piece would need to be replaced or nailed back into its proper place. The RM stated that the AFH had possession of the broken kitchen cabinet drawer. The RM stated that it would fix the broken kitchen cabinet drawer.
