Personal Care

1. EATING

If needed, the home may provide assistance with eating as follows:

From cuing and monitoring to full assistance.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

From cuing and monitoring to full, one person, assistance.

3. WALKING

If needed, the home may provide assistance with walking as follows:

From cuing and monitoring to full one person assist.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

From cuing and monitoring to full, one caregiver performance, including hooyer lift.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

From cuing and monitoring to full, one person assist. alternating pressure mattresses and chair cushions are being used for pressure relief.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

From set up to full caregiver performance.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

From cuing and monitoring to full assist.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

From cuing and monitoring to full, one person assistance. Wheel in shower ,shower commode/bench, hand shower.

Medication Services

The home has the ability to provide the following skilled nursing services by delegation:

Respiratory treatments, foley catheter, tube feeding, non sterile dressing, topical ointments, suppositories, eye drops, nasal spray, insulin administration. No IV medications.
