### Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

**1. EATING**

If needed, the home may provide assistance with eating as follows:

**All help with eating will be provided from cuing, monitoring, cutting up food, special diets, to total feeding assistance or feeding tubes**

**2. TOILETING**

If needed, the home may provide assistance with toileting as follows:

**The home will provide all toileting assistance, bed pans, to catheter care, toilet schedules,**

**cuing, and monitoring to total assistance.**

3. WALKING

If needed, the home may provide assistance with walking as follows:

**All walking assistance will be provided including stand-by- assist or one person assist.**

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**All transferring assistance will be provided including stand-by assist or one to two person physical assist. Hoyer transfers or any other mechanical transfers**

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**All positioning assistance will be provided including cuing and monitoring to one person physical assist, every two hours repositioning to bed or wheelchair bound clients.**

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**All personal hygiene assistance will be provided including cuing and reminders to total assistance.**

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

**All dressing assistance will be provided from cuing and reminders to set up and total assistance. Dressing assistance includes dressing appropriately for occasion, weather and cleanliness.**

8. BATHING

If needed, the home may provide assistance with bathing as follows:

**All bathing assistance will be provided from reminders to total assistance.**

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

**Many varieties of special equipment's will be available for assistance with personal care as shower chairs,**

**Medication Services**

**Staffing**

A resident manager lives in the home and is responsible for the care and services of each resident at all times.

The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
