**Personal Care**

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

*a dedicated caregiver will be assigned to resident needing help*

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

*the caregivers will give toileting assistance when necessary*

3. WALKING

If needed, the home may provide assistance with walking as follows:

*the caregivers will assist the residents needing assistance*

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

*the caregivers will provide assistance when transferring.*

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

*the caregivers will provide with positioning when needed.*

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

*the caregivers will provide with personal hygiene when necessary*

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

*The caregivers will provide with dressing when needed.*

8. BATHING

If needed, the home may provide assistance with bathing as follows:

*the caregivers will assist in bathing when necessary*

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

*The homecare will provide necessary assistance to residents*

**Medication Services** *needing help*

**Staffing**

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: 7 days 8a-10a + 24 hrs on call
- Licensed practical nurse, days and times: \_\_\_\_\_
