**Personal Care**

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

**Mariam's compassionate care will provide the following, Services may include but limited to: monitoring and cueing clients who are at risk for choking and aspiration, prompting to eat, cut up or puree food, feeding clients as indicated.**

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

**Mariam's compassionate care will provide the following, Services may include but limited to: Provide complete toileting, including bedside commodes, urinals, incontinent care. Bladder training Changing of briefs/pads when necessary.**

3. WALKING

If needed, the home may provide assistance with walking as follows:

**Mariam's compassionate care will provide the following, Services may include but limited to: Cueing client on correct use of all medical devices, physical assistance during transfers and ambulation, standby or contact assist to prevent or avoid falls or injuries.**

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**Mariam's compassionate care will provide the following, Services may include but limited to: Provide Hoyer lift transfers as indicated, physical assistance from/to bed/wheelchair, shower/bathing and lifting assistance.**

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**Mariam's compassionate care will provide the following, Services may include but limited to physical assistance during sitting, cueing and reminding clients to change position or turn, Provide repositioning on a regular 2-3 hour schedule for clients at high risks fo skin breakdown or bedsores.**

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**Mariam's compassionate care will provide the following, Services may include but limited to verbal cueing/reminders, set up and hand assistance, assist with showers at least twice a week or as client's preference, Assist with bed bath if client is unable to use shower. Assists with oral care, shaving and hair styles, assist with nail care and trimming, application of deodrant and lotion, provide encouragement to promote and maitain independence**

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

**Mariam's compassionate care will provide the following, Services may include but limited to: Supervise and standby assist durng dressing, Provide total assist with dressing, Offer choices for resident's preference, provide encouragement to promote and maitain independence.**

8. BATHING

If needed, the home may provide assistance with bathing as follows:

**Mariam's compassionate care will provide the following, Services may include but limited to, Supervision during showers. cueing during shower, skin assessment during shower and when indicated, provide encouragement to promote and maitain independence.**

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

**Exceeding all expectations is our focus.**

**Medication Services**

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

**Medication assistance/administration will only be conducted per Assessment and NCP, Dispensing of medication will be conducted in accordance to clients doctors order. Certain tasks may be delegated such as crushing medication (per doctors order). Medication logs will be strictly supervised/monitored, and any delegation task will be properly documented.**

**Staff at Mariam's Compassionate care have been delegated in various tasks, and due to various levels of care, we contract with an outside nurse**

ADDITIONAL COMMENTS REGARDING MEDICATION SERVICES

**Because the facility varing levels of care, we contract with an outside nurse for delegation.**

**Skilled Nursing Services and Nurse Delegation**

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

**Through Nurse Delegation only.**

The home has the ability to provide the following skilled nursing services by delegation:

**Yes: crushing of meds, hospice care medication, insulin injections, diabetic care, tube feeding, dressing change only(for wound/skin care), catheter care, (maintaining, cleaning and changing of bags only).**

**Staffing**
