The Department completed a complaint investigation of your Adult Family Home on June 1, 2021 and found that your home does not meet the adult family home licensing requirements below.

**Consultation:**

**WAC 388-76-10025 License annual fee.**

- (1) The adult family home must pay the license fee that is established in the state's operating budget, as described in RCW 70.128.060 .
- (2) Each year, the home's annual license fee is due during the same month in which the home was initially licensed. For example, if the home was licensed in June, 2010, then the annual licensing fee will be due in June of each year.
- (3) The home must ensure that the department receives the annual license fee when it is due.

The Adult Family Home (AFH) failed to pay annual license fees during the month of March 2021. Staff A, AFH Provider stated they overlooked the due date for the licensing fee. Staff A stated they mailed the full payment to the Department on 05/01/2021 and the check cleared their bank account on 05/11/2021.

You Must:

- Begin the process of correcting the deficiency or deficiencies immediately; and
- Complete correction as soon as possible.

You Are Not:

- Required to submit a plan-of-correction for the deficiency or deficiencies found.

The Department May:

- Inspect the home to determine if you have corrected all deficiencies.

You May:

- Ask for an informal dispute resolution meeting, according to the attached "Informal Dispute Resolution" instructions; and

**Allegation Summary:**

#1. Review of Department records showed the AFH annual license fees were due 03/15/2021 and on 05/04/2021 the AFH had a balance owing.

During an interview, AFH Provider stated they overlooked the due date for the licensing fee. Provider added they mailed the full payment to the Department on 05/01/2021 and the check cleared their bank account on 05/11/2021.

Further review of department records on 05/26/2021 showed a license fee balance of zero. Department staff confirmed the Department received the full payment on 05/10/2021.

During interviews with department staff, residents denied any concerns with care.
