Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Supervising & cueing clients who are at risk for choking/aspiration**
- * **Altering texture of food, i.e. cutting food into small pieces, chopping, pureeing solid foods**
- * **Feeding clients as indicated by the assessment**

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Reminding residents to visit the bathroom regularly**
- * **Supervising/providing stand-by assistance while toileting**
- * **Changing briefs/pads and incontinence care as needed**

3. WALKING

If needed, the home may provide assistance with walking as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Cueing residents to use assistive devices**
- * **Stand-by/partial physical assistance with/without the use of gait belt during walking**
- * **Encourage regular exercise**

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Supervise/stand-by assistance with transfers**
- * **One-staff assistance with transfers**
- * **Provide Hoyer lift transfers**

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Cueing/reminding or partial assistance to change position/turn**
- * **One-staff assistance with changing position/turning while in bed or chair**
- * **Provide regular repositioning for residents at high-risk for skin breakdown**

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Cueing, stand-by or one-staff assistance involving a wide range of services, i.e. bathing, shaving...**

If needed, the home may provide assistance with dressing as follows:

When deemed appropriate by the provider, the AFH may provide the following:

*** Cueing, stand-by or one-staff assistance**

8. BATHING

If needed, the home may provide assistance with bathing as follows:

When deemed appropriate by the provider, the AFH may provide the following:

*** Cueing, stand-by or one-staff assistance for a showers, assessing skin...**

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

Cueing, reminding, one-staff assistance for medications. Medications are stored in locked storage. Nurse delegation and qualified staff are trained to administer medications.

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)
