Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

Verbal cueing to administration of Nutrients through Tubefeeding

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Verbal cueing to total assist with toileting including providing good peri care during incontinence care

3. WALKING

If needed, the home may provide assistance with walking as follows:

The AFH only accepts Residents that are independent with ambulation without using any assistive device

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Verbal cueing, stand-by assistance for Resident's safety

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Verbal cueing or stand-by assistance while Resident is repositioning self for safety

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Verbal cueing to total assist with performing personal hygiene tasks

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Verbal cueing to total assist with dressing, encouraging residents to verbalize their preference on the clothes to wear.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Verbal cueing to total assist with bathing. Daily sponge bath or showers

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

Medication assistance through handling medications to residents with the use of enabler to administering medications either by mouth, nose, ears, eyes or topical medications.

(WAC 388-76-10405)

Insulin injection, instillation of eyedrops, eardrops, application of topical medications. inhalers

Staffing

The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
