### Personal Care

#### 4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**from cuing and monitoring, total assistance with the use of, gait belts and other safety measures**

#### 5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**from cuing and monitoring to total assistance**

#### 6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**from cuing and monitoring to total assistance**

#### 7. DRESSING

If needed, the home may provide assistance with dressing as follows:

### Medication Services

(WAC 388-76-10040)

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
