Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

Our staff is well trained to provide meals prep, meals set-ups and assistance to those who require physical assistance as well as tube feeding.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Staff will provide assistance with all toileting needs patiently and accommodate toileting schedule.

3. WALKING

If needed, the home may provide assistance with walking as follows:

Staff will provide assistance with supervision, contact and physical assistance with ambulation

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Staff will provide assistance with mobility and locomotion including use of mechanical devices as fit for each resident.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Staff will provide assistance with positioning including cueing, physical assistance

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Staff is well trained to provide personal hygiene on all levels of assistance.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Staff will provide dressing on all levels of assistance.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Staff will provide bathing on all levels of assistance.

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

Staffing

(WAC 388-76-10040)

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
