Instructions for Notice of Termination Form

Submit a Notice of Termination Form to (NOT) the Department of Ecology when all activities have been completed and a Project Completion Report has been submitted or is included with this NOT.

- I. **Operator** Give the name, address, and telephone number of the person who is responsible for the permit.
- II. **Site Location** Enter the location description, including the city or nearest city and county, Lat/Long, river crossing, waterbody affected.
- III. **Type of Activity** Check applicable activity.
- IV. **Certification of Permittee(s)** Read this statement carefully. The operator, or authorized representative of the operator, must print his or her name for clarity, then sign and date the document on the lines provided. (Refer to General Condition G17 in the permit for signatory requirements.)
