Cleanup is complete!

Cleanup is complete at the Winger Land Golden Homes Site (Site). The Site is located at 19647 Viking Way NW, Poulsbo, Washington.

The Department of Ecology is now proposing to remove the Site from the state's Hazardous Sites List, a statewide record of contaminated properties. The Site underwent a Site Hazard Assessment and was ranked "3" on a scale of 5 where "1" represents the highest risk and "5" is the lowest risk. This ranking estimates the potential threat to human health and the environment relative to other sites in Washington State.

We invite your comments through September 10, 2018 on the proposed delisting. On the left are document review locations where you can find the No Further Action letter that describes how the Site was cleaned up and why Ecology has determined that the cleanup is complete.

Why this cleanup matters

In 2003, contamination from gasoline, benzene, ethylbenzene, and xylene was found in Site soil samples. These products can be carcinogenic and harm people's health and the environment.

Cleanup activities

The property owners conducted this cleanup under Ecology's Voluntary Cleanup Program. Site cleanup activities included:

- Studying the site thoroughly to characterize all contamination.
- Excavating two underground storage tanks and removing approximately 100 cubic yards of contaminated soil.
- Testing the soil and groundwater to confirm cleanup.
