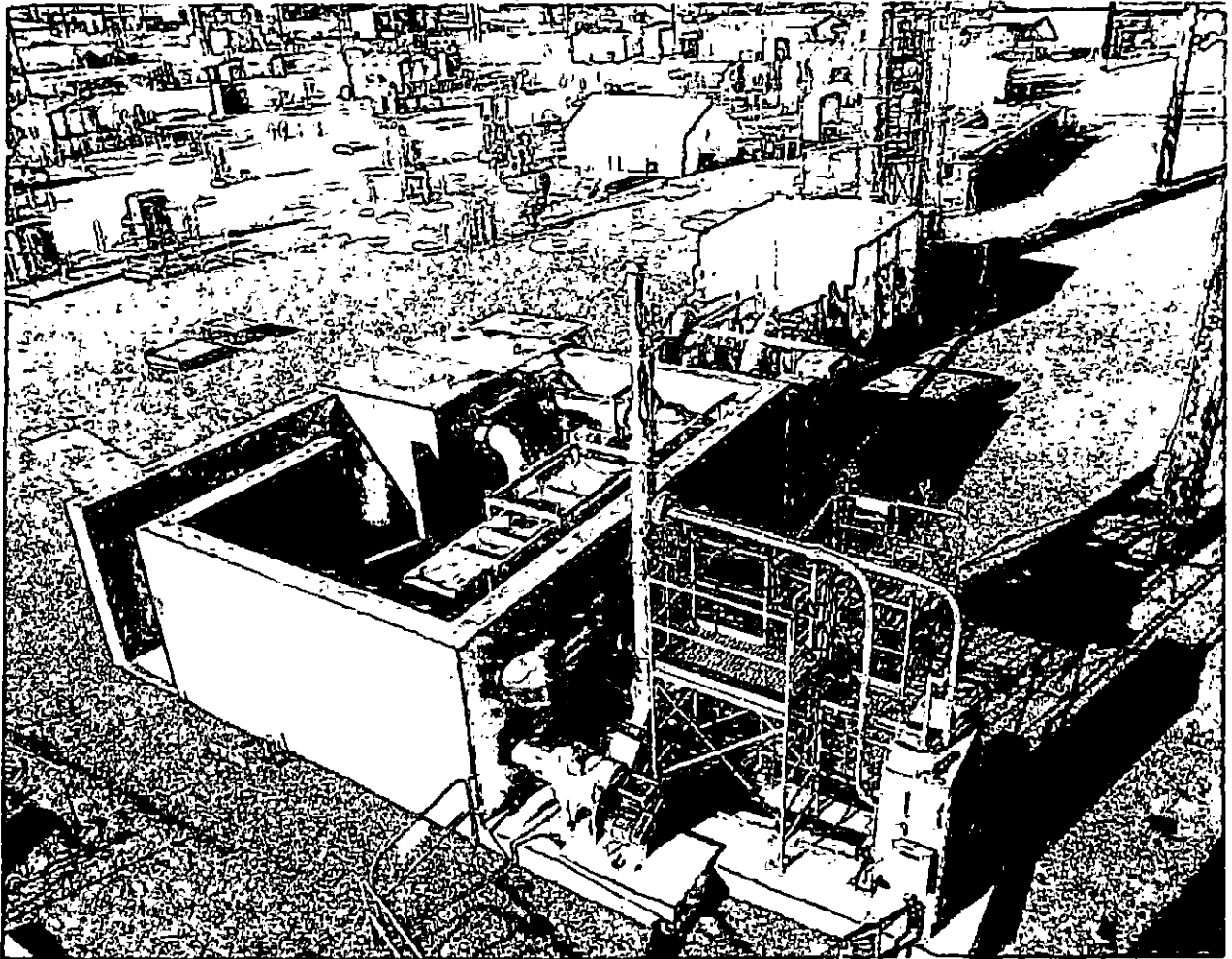

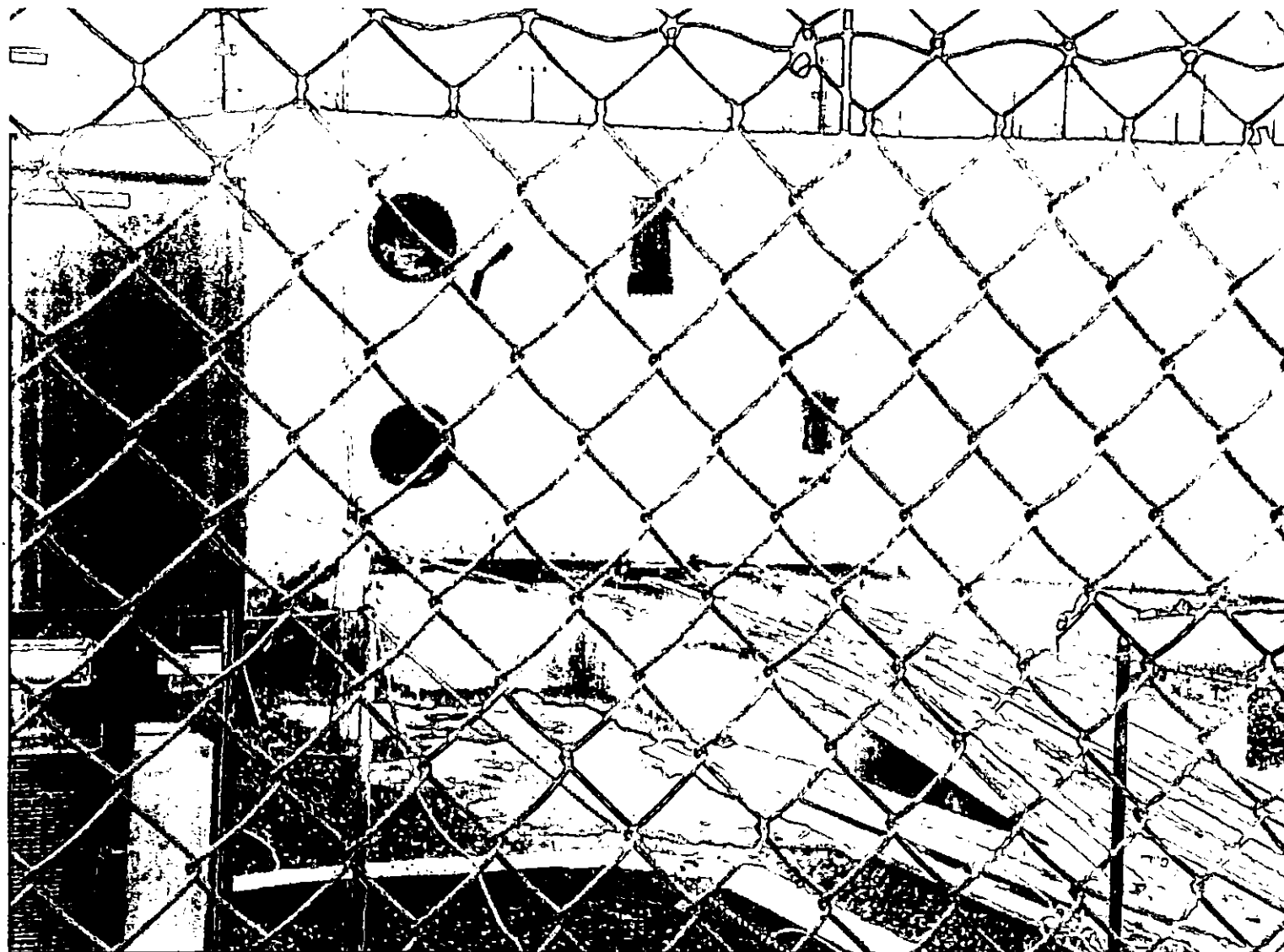

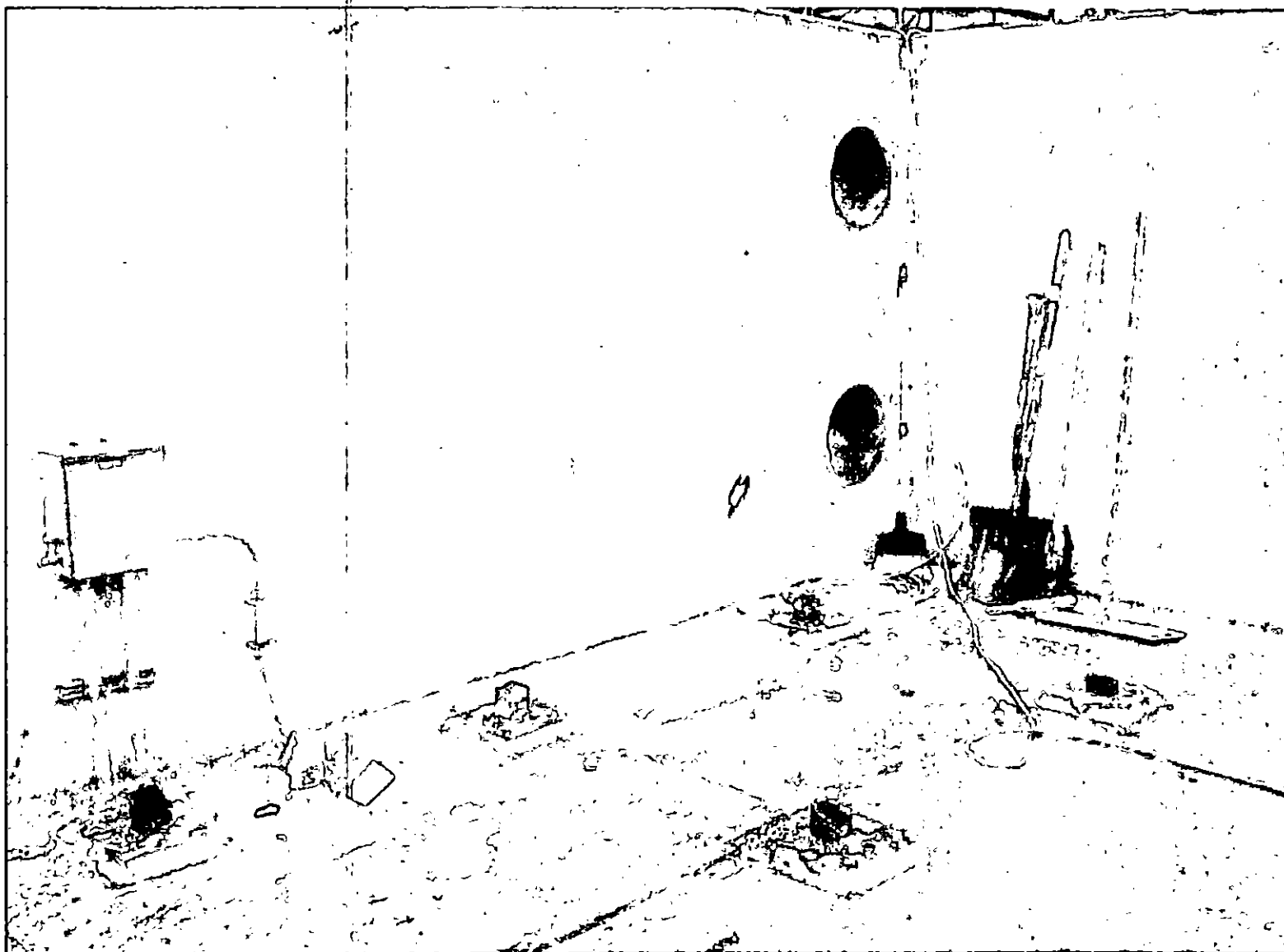
296-A-40 Demolition Scope



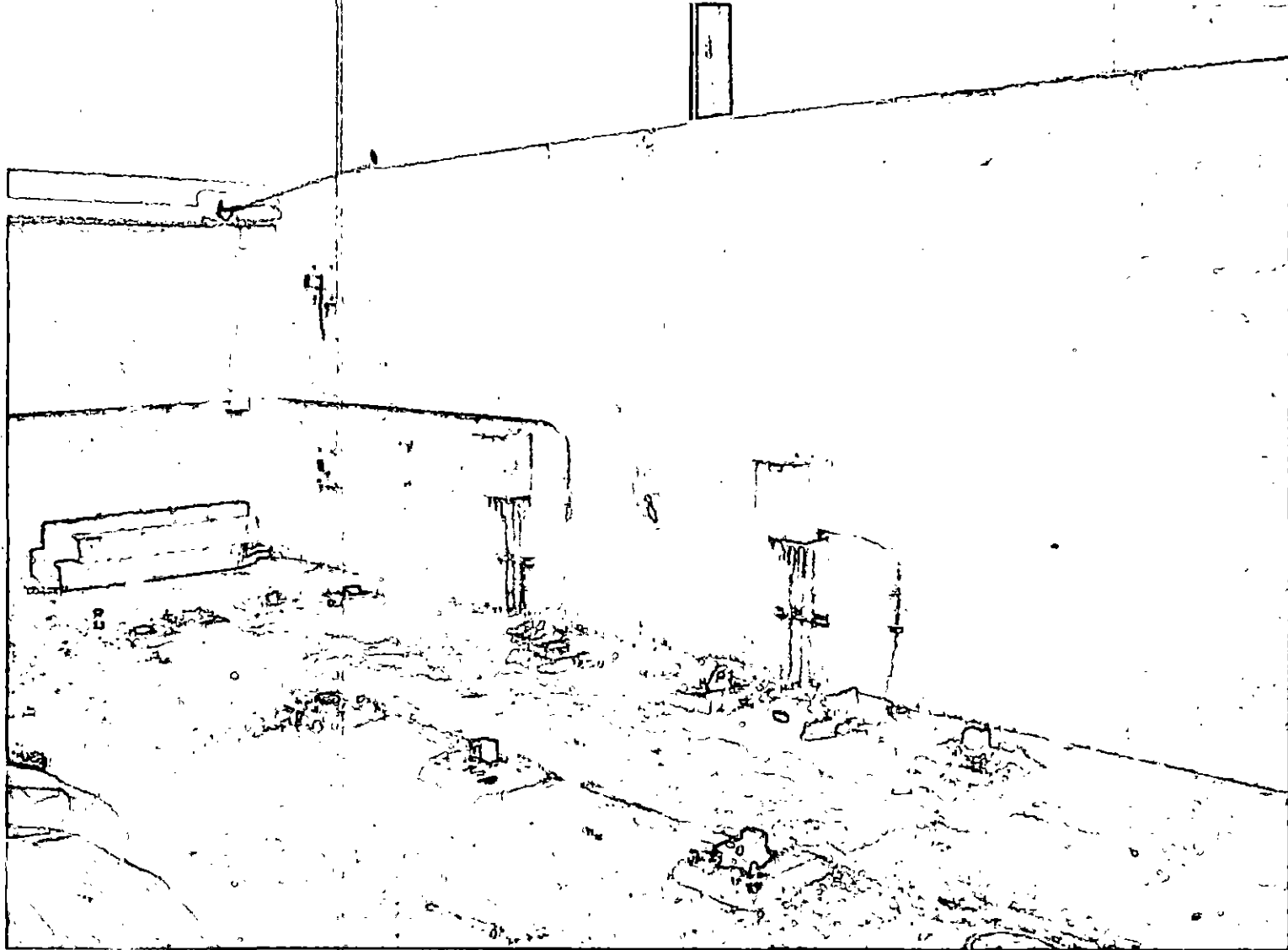
296-A-40 Exhauster Pad Location with Stack Removed



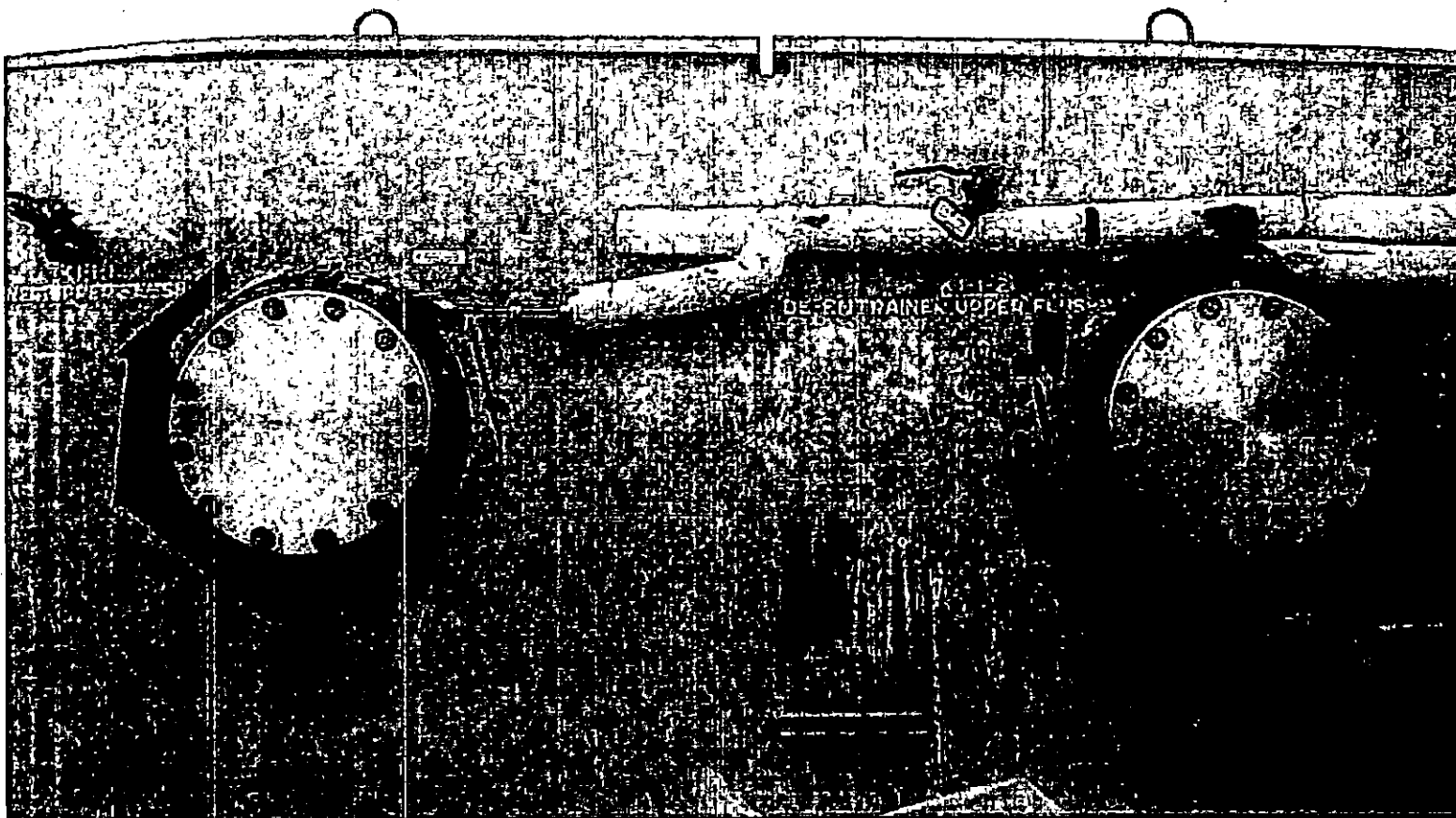
296-A-40 Exhaust Ports to Stack from inside Concrete Wall with Filter Housing Removed



296-A-40 Condensate Drain Lines with Filter Housing Removed




296-A-40 Exhaust Ports from De-Entrainers to Filter Housing Blanked Off




