



Application for a Permit to Burn Storm and Flood Debris

This is an application for a permit to burn storm and flood debris. If you plan to do land clearing or agricultural burning, please contact the Ecology regional office listed below.

Storm and flood debris is natural vegetation such as leaves and branches that is left behind by storms and/or floods. Material is considered storm or flood debris if:

- the storm or flood occurred in the last two years, and
- the city, county, or state government declared an emergency as a result of the storm or flood.

Burning is only one way to dispose of vegetative debris. *Before you get a burn permit, you must consider alternatives to burning and show that there are no reasonable alternatives. If Ecology finds there is a reasonable alternative to burning in your area, you may be denied a permit.*

If, after investigating alternatives, you decide to burn: fill out this application completely, sign the bottom, and mail or fax to the Ecology regional office listed below. If you have any questions or need help filling out the application, call your regional office and ask for a Burn Team member.
