

## Proposed Removal from the Hazardous Sites List

The Department of Ecology (Ecology) proposes taking the Tetz Oil site off the Hazardous Sites List. It is located at 2711 Ocean Avenue in Raymond. We are accepting comments on this decision through **January 30, 2015**. The box to the right shows where to find:

- A No Further Action letter that describes and approves the cleanup.
- Background information about the site.

### Site Background and Cleanup

Beginning in the 1930s, several companies used the site as a bulk fuel plant where they stored and distributed petroleum products. The property is now a WA Department of Transportation storage yard.

Sampling from 1997 - 1999 found that past activities had polluted soil and groundwater with diesel, and oil, and gasoline-range petroleum hydrocarbons.

In 2007, Chevron entered the Voluntary Cleanup Program for the site. In 2010, they removed 12.8 tons of contaminated soil. However, follow-up sampling found that a small area of contaminated soil remained.

Sampling in 2013 found that now no contamination remains above site-specific cleanup levels. Ecology considers the cleanup complete.

### What Happens Next

1. Through January 30, Ecology invites you to comment on our decision to remove the site from the Hazardous Sites List.
2. After the comment period, we will respond to comments.
3. We may require further sampling or cleanup based on information given by the public. Otherwise, we will remove the site from the Hazardous Sites List.


