Meter installation and any plumbing modifications shall be completed by December 1, 2005. Water shall be put to beneficial use consistent with these terms and conditions by December 1, 2006.
3. An approved measuring device shall be installed and maintained for each diversion of the source identified by this water right in accordance with the rule "Requirements for Measuring and Reporting Water Use, Chapter 173-173 WAC.
4. Water use data shall be recorded bi-weekly. The maximum rate of diversion and the annual total volume shall be submitted to Ecology by January 31st of the following year.
5. The following information shall be included with each submittal of water use data: owner, contact name if different, mailing address, daytime phone number, certificate/claim no., and source name. In the future, Ecology may require additional parameters to be reported or

more frequent reporting. Ecology prefers web based data entry, but does accept hard copies. Ecology will provide forms and electronic data entry information.

6. Chapter 173-173 WAC describes the requirements for data accuracy, device installation and operation, and information reporting. It also allows a water user to petition Ecology for modifications to some of the requirements. Ecology personnel, upon presentation of proper credentials, shall have access at reasonable times, to water use records kept to meet the above conditions, and to inspect at reasonable times any measuring device used to meet the above conditions.
