The City of Pateros proposes to drill 2 to 3 new wells. The City's preferred locations are listed in numerical order beginning with Proposed Well No. 3. The City does not propose to drill 17 additional wells. The additional sites are intended as back up sites. Whichever locations contain the new production wells will be referred to as Wells No. 3, 4, 5 and so on. In some cases, the City owns the subject property. In other cases, Pateros will enter into negotiations with the property owner(s) in order to access the property for production well installation and operation. With this application, the City proposes to add points of withdrawal for Water Right # G4-CV2P916 to 2 or 3 proposed new well locations.
