Proposed Works

This application seeks to change a portion of the adjudicated Court Claim S4-02084CTCL from its existing diversion on the Naches River below Twin Bridges (at river-mile 3.0), to the site of Nelson-Cowiche Dam upstream on the Naches River at river-mile 3.7. The proposed move is a component in the consolidation of irrigation water diversions managed by the City at the site of the proposed renovated dam structure. The City is proposing to move the point of diversion (POD) concurrent with reconstruction of the dam, which is intended to relieve stresses driven by problematic river aggradation.

Easement and Right-of-Way

Where the water source and/or water transmission facilities are not wholly located upon land owned by the applicant, issuance of a water right change authorization by this department does not convey a right of access to, or other right to use, land which the applicant does not legally possess. Obtaining such a right is a private matter between applicant and owner of that land.

Schedule and Inspections

Ecology personnel, upon presentation of proper credentials, will have access at reasonable times, to the project location, and to inspect at reasonable times, records of water use, wells, diversions, measuring devices and associated distribution systems for compliance with water law.

Findings of Facts

Upon reviewing the investigator's report, I find all facts, relevant and material to the subject application, have been thoroughly investigated. Furthermore, I concur with the investigator that water is available from the source in question; that there will be no impairment of existing rights; that the purpose(s) of use are beneficial; and that there will be no detriment to the public interest.

Therefore, I ORDER approval of Application No. CS4-02084CTCL, subject to existing rights and the provisions specified above.

Your Right To Appeal

This Decision may be appealed pursuant to RCW 34.05.514(3), RCW 90.03.210(2), and Pretrial Order No. 12 entered in *State of Washington, Department of Ecology v. James Acquavella, et al.*, Yakima County Superior Court No. 77-2-01484-5 (the general adjudication of surface water rights in the Yakima River Basin). The person to whom this Decision is issued, if he or she wishes to file an appeal, must file the notice of appeal with the Yakima County Superior Court **within thirty (30) days of receipt of this Decision**. Appeals must be filed with the Superior Court Clerk's Office, Yakima County Superior Court, 128 North 2nd Street, Yakima WA 98901, RE: Yakima River Adjudication. Appeals must be served in accordance with Pretrial Order No. 12, Section III ("Appeals Procedures"). The content of the notice of appeal must conform to RCW 34.05.546. Specifically, the notice of appeal must include:

- The name and mailing address of the appellant;
- Name and address of the appellant's attorney, if any;
- The name and address of the Department of Ecology;
- The specific application number of the decision being appealed;
- A copy of the decision;
- A brief explanation of Ecology's decision;
- Identification of persons who were parties in any adjudicative proceedings that led to Ecology's decision;
- Facts that demonstrate the appellant is entitled to obtain judicial review;
- The appellant's reasons for believing that relief should be granted; and
- A request for relief, specifying the type and extent of relief requested.

The "parties of record" who must be served with copies of the notice of appeal under RCW 34.05.542(3) are limited to the applicant of the decision subject to appeal, Ecology and the Office of the Attorney General.

All others receiving notice of this Decision, who wish to file an appeal, must file the appeal with the Yakima County Superior Court within **thirty (30) days of the date the Order was mailed**. The appeal must be filed in the same manner as described above.

INVESTIGATOR'S REPORT

BACKGROUND

Description and Purpose of Requested Change

On January 21, 2011, the City of Yakima (the City), on behalf of the New Schanno Ditch Company (formerly R.S.&C. Irrigation Company), filed this change application to make an upstream move of the existing diversion on the Naches River below Twin Bridges (at river mile 3.0), to the site of Nelson-Cowiche Dam upstream on the Naches River at river-mile 3.7. Water diverted at the proposed point of diversion (POD) will be conveyed down the City's general irrigation pipe and into the Fruitvale Canal near the intersection of Naches Heights Road and West Powerhouse Road. The proposed move is a component in the consolidation of irrigation water diversions managed by the City at the site of the proposed replacement dam structure. The City is proposing to move the POD concurrent with reconstruction of the dam, which is intended to relieve stresses driven by problematic river aggradation and subsequent flood control difficulties on the Naches River. For the City's irrigation department, moving the POD will also eliminate a complicated start-up process at the beginning of each irrigation season.

No other attribute changes are proposed as part of this change application. The irrigation and ditch companies represented by the City will continue to be irrigated with water from the Naches River. If this application is approved (along with the four other companion applications), it will consolidate the PODs for each of the separately-defined water rights to a single POD at the Nelson-Cowiche Dam.

This change application qualifies for expedited processing under WAC 173-152-050(2)(d) whereby water right changes or transfers may be priority processed when the proposed water use would result in providing public water supplies to meet general public needs for the regional area. The requested water right change is a component in the larger Nelson-Cowiche Dam project, whose goals include enhancing and improving water management, flood control, wetlands, fish habitat, and the reliability of water supply for existing Yakima Basin water rights.

This investigation serves as the written findings of fact concerning water right Change Application CS4-02084CTCL.

Legal Requirements for Proposed Change

The following is a list of requirements that must be met prior to authorizing the proposed change.

- **Public Notice**

RCW 90.03.280 requires that notice of a water right application be published once per week, for two consecutive weeks, in a newspaper of general circulation in the county or counties where the water is to be stored, diverted, and used.

Notice of this application was published in the Yakima Herald Republic on July 13, and July 20, 2012. No letters of protest or comments were received during the 30-day protest period.

- **Water Transfer Working Group**

This application was presented to the Yakima River Basin Water Transfer Working Group (WTWG) on November 2, 2015. Both the Yakama Nation and the Washington Department of Fish and Wildlife (WDFW) requested further analysis on potential changes to the hydrograph resulting from the upstream move in POD. This component was presented and discussed at the December 7, 2015 WTWG meeting. A representative from WDFW verbally indicated that they had no further concerns after reviewing the presented data. On December 10, 2015, the Washington State Department of Ecology (Ecology) received notification from the Yakama Nation stating that they had no further concerns with the project.

- **State Environmental Policy Act (SEPA)**

A water right application is subject to a SEPA threshold determination (i.e. an evaluation whether there are likely to be significant adverse environmental impacts) if any one of the following conditions is met:

- (a) It is a surface water right for more than 1 cubic foot per second (cfs), unless that project is for agricultural irrigation, in which case the threshold is increased to 50 cfs, so long as that irrigation project will not receive public subsidies.

- (b) It is a groundwater right for more than 2,250 gallons per minute (gpm).
- (c) It is an application that, in combination with other water right applications for the same project, collectively exceed the amounts in (a) and (b) above.
- (d) It is a part of a larger proposal that is subject to SEPA for other reasons (e.g., the need to obtain other permits that are not exempt from SEPA).
- (e) It is part of a series of exempt actions that, together, trigger the need to do a threshold determination, as defined under WAC 197-11-305.

On November 14, 2014, the City, SEPA Lead Agency for the project, determined that this project will have no probable significant adverse impact on the environment and issued a Determination of Nonsignificance (DNS) on December 1, 2014 under SEPA File No. 026-14. The DNS and entire official SEPA file for this project are available from the City of Yakima Community Development Department in Yakima, WA, at (509) 575-6183; or a copy of the DNS is available by contacting Ecology's Central Regional Office in Union Gap, WA, at (509) 575-2490.

- **Water Resources Statutes and Case Law**

RCW 90.03.380(1) states that a water right that has been put to beneficial use may be changed. The POD, POU, and purpose of use may be changed if it would not result in harm or injury to other water rights.

WAC 173-152-050(2)(d) states that Ecology may approve an application for priority processing that, if approved, would result in providing for public water supplies including, but not limited to, consolidation of two or more public water systems, to meet general public needs for the regional areas.

Tentative Determination of Extent and Validity

The Washington Supreme Court has held that Ecology, when processing an application for change to a water right, is required to make a tentative determination of extent and validity of the claim or right (See *RD Merrill v. PCHB* and *Okanogan Wilderness League v. Town of Twisp*). This is necessary to establish whether the claim or right is eligible for change. In this case, the proposed right for change has been adjudicated by the Yakima Superior Court and a Conditional Final Order (CFO) for the New Schanno Ditch Company Court Claim No. 2084 issued on April 10th, 2003. As there has been at least a 5-year period since the issuance of the CFO, a tentative determination of the extent and validity of this right is required.

INVESTIGATION

Data and information used to construct this investigation were obtained during a site visit conducted on July 8, 2014. Present during the site visit were Ecology representatives Tyler Roberts and Stan Isley, and applicant representative Dave Brown of the City. Other pertinent information was obtained from various sources internal and external to Ecology. These sources include, but are not limited to:

- Documentation submitted with the change application
- Applicable RCW and WAC chapters
- Ecology records
- Historical land and aerial photographs
- Data submitted by the applicant concerning the historical quantity of diverted water
- Water Resources Program Geographic Information System (GIS) data
- In-person meetings, discussions, and presentations with involved personnel from the City, WDFW, U.S. Bureau of Reclamation (USBR), and Yakima County Flood Control Zone District (Flood Control)
- Court documentation such as the CFO and Report of Referee (RoR)

History of Water Use for Court Claim No. 2084

The current New Schanno water right claim originated with the R.S.&C. Irrigation Company (R.S.&C.). Court Claim No. 2084 was filed in *Department of Ecology v. James J. Acquavella, et al. (Acquavella)* by R.S.&C., claiming irrigation water for 750 acres from the Naches River. Testimony at the Evidentiary Hearing (outlined in the RoR for Subbasin 19; hereafter, RoR) stated that the R. Strobach Ditch Company (Strobach) was a predecessor to the R.S.&C. Ditch Company, and that the appropriations made by Strobach were the basis for R.S.&C.'s claims. No notice of appropriation was supplied at the Evidentiary Hearing, but the Court noted that a fire at the Yakima County Courthouse in 1882 would likely have destroyed this and similar records. Alternatively, testimony on behalf of R.S.&C. identified minutes from an R.S.&C. shareholder meeting from May 26, 1982 as evidence of organization and incorporation of the company.

A key element of the R.S.&C. claim is the shared POD and conveyance ditch with other nearby ditch companies, now commonly referred to as Fruitvale Canal. This is conditioned by a April 16, 1904 agreement with the Northwest Light and Water Company (Northwest Light) to share use of Fruitvale Canal with Northwest Light, New Schanno Ditch Company, Fruitvale-Schanno Ditch Company, and the R.S.&C. Ditch Company. This agreement stipulated that R.S.&C. was entitled up to 19 cfs.

On March 12, 1906, R.S.&C. and the United States entered into an agreement limiting R.S.&C.'s diversion from the Naches River to 12.0 cfs from April 1 to August 31, 8.0 cfs during September, and 6.0 cfs in October.

On December 16, 1974, R.S.&C. filed Water Right Claim 094489 pursuant to Chapter 90.14 RCW. R.S.&C. claimed present use of 12.0 cfs from April 1 to August 31, 8.5 cfs for September, and 6.0 cfs from October 1 through October 15, 4,166 acre-feet per year, for municipal use from the Naches River for

470 acres of irrigation. The claim lists as the legal description of the POU as the "City of Yakima", and 1873 as the date of first beneficial use.

On October 14, 1993, the Court granted a motion to transfer the R.S.&C. claim into the Major Claimant Pathway from Sub-basin 19 (Lower Naches).

On April 10, 2003, the Court issued the CFO for Court Claim No. 02084 with the following provisions:


- 1) The point of diversion is located approximately 2,500 feet north and 100 feet west of the southeast corner of Section 9, being within the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 9, T. 13 N., R. 18 E.W.M.
- 2) Priority date is June 30, 1873.
- 3) The purpose of use is irrigation of 104 acres of residential, commercial and agricultural land.
- 4) The place of use is described in RSC 18 and identified on COY 15G-1 (Upper RS&C) and COY 15H-1 (RS&C).
- 5) The season of use is April 1 through October 31.
- 6) RS&C is authorized to divert from the Naches River into the Fruitvale Canal 1,746 acre-feet per year with the following schedule of delivery:
 - 5.3 cubic-feet per second from April 1 through August 31.
 - 3.56 cubic-feet per second from September 1 through September 30.
 - 2.66 cubic-feet per second from October 1 through October 31.

The Court also found the following:


- 1) RS&C's claim to an unauthorized or *de facto* change in point of diversion is denied.
- 2) RS&C's claim to a standby or a reserve supply is denied.
- 3) RS&C's claim to a municipal supply is denied.
- 4) RS&C's water right pursuant to the unassigned shares is relinquished for failure to put water to beneficial use or supply a sufficient cause for nonuse.

On September 12th, 2005, the Yakima County Superior court issued order No. 77-2-01484-5 substituting New Schanno Ditch Company for R.S. & C. Irrigation Company.

Tentative Determination of Extent and Validity

An analysis of the tentative extent and validity for this right was performed using two methods:

- 1) **Aerial Photography.** Aerial photographs from 2003 to 2011 were obtained from Water Resources' GIS. These aerial photographs were reviewed to assess the irrigated areas after 2003 per RCW 90.14.160. Based on aerial photographs taken during 2005, 2006, 2009, and 2011, it

appears the entire POU has been irrigated since 2003, supporting continuous beneficial use to the extent of the right specified by the Court in the Conditional Final Order.

- 2) **Flow Data.** Flow data for the Fruitvale Canal—the conveyance source for New Schanno (01210CTCL), Broadgauge/New Schanno (01213CTCL), Fruitvale-Schanno (01214CTCL), and RS&C/New Schanno (02084CTCL)—provided by the City and USBR support continuous beneficial use to the extent of the right specified by the Court in the 2003 CFO. These data provide monthly diversion quantities by maximum cubic feet per second, and annually by acre-feet per year, between April 1996 and October 2013. Flow data by month are listed in APPENDIX 2.

Other Water Rights Appurtenant to the Proposed POU

The designated POU and historic use for the City's irrigation water right cover a large area, with the POU serving as a service area for a delivery system managed by the City. Historic beneficial use is spread over the lawns and gardens of residents inside the boundary of the POU. Additionally, there are many other water rights and claims to a water right that overlap the area served by the City of Yakima under CS4-02084CTCL. An analysis of Water Resources' GIS identified 72 water rights, claims to a water right, permits, and applications which at least partially overlap the POU of the subject right. Additionally, there are 24 water rights and claims to a water right with a source (but not necessarily a POU) located within the POU for the subject right.

Ecology is unable to discern at this scale which of these overlapping rights use water separate from the City distribution system. However, the City manages distribution of irrigation water within the POU for this right such that the additive quantities are not exceeded.

A complete listing of the above water right documents is below in Appendix 3.

Impairment Considerations

RCW 90.03.380 provides that a perfected water right may be changed in several ways, provided that the change will not impair the right of another water right holder.

The most significant issue in this application is the upstream diversion move on the Naches River. An upstream change results in an affected reach, defined by the section of the Naches River between the current POD location and the proposed POD location. The current POD is at the Fruitvale Canal diversion, located at approximately river-mile 3.0, and the proposed POD is at the site of the proposed Nelson-Cowiche Dam project at approximately river-mile 3.7, immediately west of the intersection of US 12 and the Naches River. The length of the affected reach is approximately 0.76 miles long. Any diversions located within this affected reach have the potential to be impaired or impacted by this proposal. However, there are no intervening surface water rights in the Naches River between the current POD and the proposed upstream POD on file with Ecology.

In general, upstream diversion moves have the potential to adversely affect fish habitat; the nature of this project allays this concern. The overall scope of this project is an inter-agency effort to both improve fish habitat and populations, and alleviate potentially destructive floodplain processes of the Naches River. Combining PODs for the five change applications by the City will allow the removal of

several irrigation control apparatuses, which is expected to benefit anadromous and resident fish species and populations.

As a consequence, there are substantial environmental benefits to both the upstream move of the POD and the dam project. These benefits dispel the most common objections to upstream moves—problems stemming from removal of water for a reach of the river or stream—and alleviate ongoing flood plain (geomorphological) problems currently plaguing the river and the nearby affected communities of Glead and Naches.

On May 5, 2011, Ecology received a letter from USBR supporting the upstream move and supporting the City's five change applications.

Consideration of Protests and Comments

There were no protests or comments filed in response to the public notice for this proposed application.

CONCLUSIONS AND RECOMMENDATIONS

In accordance with Chapter 90.03 RCW, the author concludes that the water right confirmed under Court Claim No. 02084 with a priority date of June 30, 1873, is in good standing and is eligible for change. Approval of this change to change the POD will not cause impairment, nor will it enlarge the subject right.

Based on the above investigation and conclusions, the author recommends that the request for change be approved in the amounts and listed below and as provisioned in the Report of Examination above.

Authorized Quantities

Authorized quantities are provisioned in the *Acquavella* Draft Schedule of Rights for Court Claim No. 02084, such:

From the Naches River:

- 5.30 cubic-feet per second from April 1 through August 31.
- 3.56 cubic-feet per second from September 1 through September 30.
- 2.66 cubic-feet per second from October 1 through October 31.
- 1,746 ac-ft/yr.

Purpose of Use

Irrigation of 104.0 acres of residential, commercial, and agricultural land.

Point of Diversion

Approximately 1,790 feet south and 1,600 feet east from the northwest corner of Section 9, being within the SE¼NW¼ of Section 9, T. 13 N., R. 18 E.W.M., Yakima County.





