**RE: Trust Water Donation Application CG4-GWC07587 for Peregrine Columbia River, LLC**

Dear Mr. Marquis:

The above referenced trust donation application received on July 1 of this year, requesting a back dated donation starting in November of 2008, cannot be processed as submitted. Ecology does not accept donations for any irrigation season completed prior to the date the application was received. Donation applications need to be submitted before the donation of water is to take place.

Since you requested the donation begin at the end of the 2008 irrigation season, there is the implication that the water has not been put to use since that time. Ecology can only accept a trust water right donation to the extent to which the water right was exercised during the five years before the donation.

An end date to the donation is also required at the time it is submitted. A donation can be extended, changed or removed from the Trust Water Right Program (TWRP) by making the request in writing 30 days prior to the needed change. I would recommend requesting a donation term of several years if there are no specific plans to use the water in the near future.

To process the donation so that it can apply to this year and future irrigation seasons, we will need information that explains when irrigation water was last used on the property. Also identify any exemptions under RCW 90.14.140 that apply due to five or more years of non-use of that portion of the water right (if needed), and include a donation end date.

Please provide the requested information by October 17, 2013, to avoid the possibility of the application being rejected.


