Project Summary (Please be specific about every detail):

The project area is located in the SW1/4 SW1/4 of Section 21, and that portion of the NW1/4 NW1/4 of Section 28 lying north of Cherry Creek and east of Cooke Creek; W1/2 NE1/4 SW1/4 of Section 21; NW1/4 SW1/4 of Section 21, all in T. 17 N., R. 19 E.W.M.

The project area property has traditionally been irrigated with water from Cooke and Parke Creeks. There is one gravity unscreened irrigation diversion on Cooke Ck and one gravity unscreened irrigation diversion on Parke Ck that are used to irrigate 77.9 acres. The Parke Ck diversion irrigates 46.2 acres and the Cooke Ck diversion irrigates 31.7 acres. The property is rill irrigated with gated pipe and concrete ditch with siphon tubes.

This project will convert 69 acres of the property to pivot sprinkler irrigation. The remaining property will continue to be rill irrigated. The majority of the Cooke Ck diversion will be moved downstream to Cherry Ck but a small amount of water (enough to irrigate 3.9 acres) will be moved upstream approximately 1,790 feet to an existing gravity diversion that will be screened in the near future. The Parke Ck diversion will be moved downstream to Cherry Ck. Moving the diversions downstream to Cherry Ck will allow the pump station to utilize water from both Cooke and Parke Creeks as allowed by the two water rights.

The saved water from both sources is estimated at 0.7172 cfs and 106.24 acre feet. Therefore 0.608 cfs and 63.44 acre feet will be trusted for instream flows in Parke Ck, 0.028 cfs and 10.93 acre feet will be trusted for instream flows in Cooke Ck (1876) and 0.0812cfs and 31.87 acre feet will be trusted for instream flows in Cooke Ck (1884).

Cooke and Parke Creeks are part of the Upper Yakima Suspended Sediment TMDL. The pivot sprinklers are estimated to reduce soil erosion by 1.7 tons per acre per year in this project area. The estimated soil savings is 117.3 tons per year.

POD #1: 140 ft south and 50 ft east of the center of Section 21 being within the NW1/4 NW1/4 SE1/4 of Section 21, T. 17 N., R. 19 E.W.M.
When surplus water is available in excess of that needed to satisfy all existing rights to Cooke Creek, an additional 0.2 cfs may be diverted. This water will normally be available approximately 30 days during the spring, which would result in up to 11.88 acre-feet per year being used in addition to that authorized herein.

Certain applications may incur a Real Estate Excise Tax liability for the seller of the water rights. The Department of Revenue has requested notification of potential taxable water right related actions and therefore may be provided with a copy of this request.
