

**6. Remarks and Other Relevant Information:**

By this Application, one half (1/2) of the annual quantity only (Qa) under the subject water right (55.25 AF/y) is to be entered into the Washington Trust Water Rights Program for the Yakima River Basin, RCW 90.42.080 and RCW 90.38.020, for enhancement of instream flows. The trusted portion of the water right shall remain in trust for a period of ten (10) years, commencing April 1, 2015, except as may otherwise be determined by Applicant and communicated to the Department of Ecology. The entire Qi under the subject water right (0.56 cfs), plus one-half of the Qa (55.25 AF/y) will be retained for the existing out-of-stream (irrigation and stock water) purpose.

Applicant's property, including the authorized place of use under the subject water right, is within a low-lying area that slopes gradually in a generally northeast-to-southwest direction toward the Yakima River. Additionally, the area is affected by the Manastash Ridge lying generally to the south. Both of these influences allow substantial irrigation water runoff from neighboring (up-gradient) irrigated farming operations. Applicant is able to capture and beneficially use this runoff or return flow water on the place of use for the subject water right. Accordingly, Applicant requests approval to enter into trust one-half (1/2) of the annual quantity only (Qa) under the subject water right, while continuing to irrigate the full 13 authorized acres under the subject water right, utilizing (1) the retained, on-farm portion of the water right (0.56 cfs, 55.25 AF/y), plus (2) captured runoff or return flows from up-gradient irrigation.

\* The Prior Change Authorization incorrectly identified the parcel containing the existing, authorized Point of Diversion as 171929-000-00013. As noted in Section 3.A., above, the correct parcel number/POD location is 171929-000-00003. Following the Prior Change Authorization, the POD for out-of-stream uses is located 491 feet south of the northeast corner of Section 29, T. 17 N., R. 19 E.W.M., Kittitas County, State of Washington. This POD description varies by a matter of a few feet from POD descriptions approved by the *Acquavella* Court for Applicant's 44-acre irrigation right under Court Claim No. 01448 and 94-acre irrigation right under Court Claim No. 01041 (both of which are also the subject of concurrently filed Change Applications to the Board). In fact, all three water rights share the same, authorized POD; minor discrepancies in the POD descriptions among the three rights are attributable only to measuring or surveying error.

\* The Prior Change Authorization incorrectly identified the Place of Use as being, "That portion of the SE ¼ NW ¼ of Section 29, T. 9 N., R. 19 E.W.M...." As noted in Section 5.A., above, the correct legal description and parcel number for the POU under the subject water right is: That portion of the SE ¼ NE ¼ of Section 29, T. 17 N., R. 19 E.W.M.... (Parcel No. 171929-000-0013).






