6. Remarks and Other Relevant Information:

PODs #1 and #2 are located approximately 1250 feet SW and 1330 feet SW of the NE corner of Section 31, respectively. The landowner and water right holder operates a campground resort with three distinct camp areas. One camp area is located outside the certificated place of use. However, this camp area has been operational for approximately 25 years and the landowner continues to operate at approximately the certificated surface water right Qa and Qi.

This application will switch the POD from a surface diversion to a ground water well and change the place of use on the water right certificate to include all service areas on the applicant's property. Additionally, the application will consolidate the community domestic and irrigation diversions into a single POD.

Project goals are to enhance instream flow, remove a fish passage barrier, improve a water supply system, and correct water right information. Instream flows will be enhanced by 0.27 cfs from the new POD to the mouth of Clear Creek. Removal of the diversion dam will permit access to quality upstream habitat for steelhead and bull trout listed under the Endangered Species Act. Instream flow enhancement and removal of fish passage barriers are described as priority actions in numerous fisheries restoration and watershed planning documents developed to guide management actions in the Wenatchee River Basin (e.g., Upper Columbia Biological Strategy, Wenatchee Watershed Plan, and Northwest Power and Conservation Council Wenatchee Subbasin Plan).

POD #1 is used year-round for domestic community supply and POD #2 is used seasonally from May 15 through September 30 to irrigate 10 acres of grass fields.

The community domestic and irrigation surface points of diversion will be consolidated to a single ground water well, and the maximum instantaneous diversion quantities will be reduced as described in the "Proposed Purpose of Use" section of this application. The maximum irrigation diversion quantity will be reduced according to data from the Washington Irrigation Guide regarding the required water to irrigate 10 acres of pasture/turf in the Leavenworth area. The maximum community domestic diversion quantity will be reduced according to resort operational needs. The proposed place of use boundary follows parcel boundary lines for all current water service areas.

The applicant utilizes the full authorized Qa for community domestic and irrigation portions of the consumptive component of the water right so no change is proposed to the annual quantities diverted.

Water will continue to be moved through the existing distribution system, which is capable of serving both the irrigation infrastructure as well as the community domestic supply.
