**6. Remarks and Other Relevant Information:**

1. Applicant's POD is the consolidated MDWA diversion on Manastash Creek: 500' south and 150' east of the north quarter corner of Section 14, being within the NW 1/4 NE 1/4 S. 14, T. 17 N., R. 17 E.W.M.
2. This Application is being submitted with eight (8) other companion applications to address Applicant's Manastash Creek irrigation rights under Court Claim Nos. 00657 and 00457, all of which have separately defined, but generally contiguous – and in some cases, partially overlapping – places of use on lands lying north of the Creek and south and east of the mainstem Yakima River. Together, these applications seek permanent recognition and approval of a single, common place of use for all of these rights, consistent with the *Acquavella* Court's February 9, 2012, Order *Pendente Lite* Re: Temporary Change in Places of Use, a copy of which is attached hereto. The proposed place of use described in Section 5.B. is identical to the exterior boundaries of the (pre-Order) aggregated places of use for all nine water rights. Applicant does not seek to transfer water to any lands that have not already been designated as places of use under at least one of the subject water rights.
