


Washington Water Trust is requesting a temporary transfer (change) to a portion of Court Claim No. 01863 with a priority date of June 30, 1886 to instream flow from May 01, 2012 through December 31, 2026.  
  
This Change Application seeks to effectuate a transfer of the 2.16 acres served by the Court Claim as partitioned and modified by ROE No. CS4-01863CTCL@9 to be used exclusively for instream flows for fish maintenance and enhancement, recreational uses and preservation of environmental and aesthetic values as allowed under RCW Chapters 90.03, 90.42, and 90.38. Water use changes associated with this application will provide significant environmental benefits from the Teanaway River to the Pacific Ocean, thus this transfer should receive expedited processing under WAC 173-152-050(2)(b) and (3)(a).  
  
This application is accompanied by a June 14, 2012 Order Pendente Lite signed by the Yakima County Superior Court.  
  
Washington Water Trust intends to protect this trust water right as instream flow from the Teanaway River to the Pacific Ocean.

Certain applications may incur a Real Estate Excise Tax liability for the seller of the water rights. The Department of Revenue has requested notification of potential taxable water right related actions and therefore may be provided with a copy of this request.




