The DNR acquired a portion of Part 1) of Change Authorization No. CS3-22005C(B)@2. The entire instantaneous and annual quantity for Part 1 of this Change Authorization is described in Department of Ecology's 1/24/2011 Modification Order as 31.34 cfs and 7,616 acre-ft/yr. DNR acquired the place of use and the following portion of the instantaneous and annual quantities for Part 1): 27.43 cfs and 6,666 acre-ft/yr. The balance of 3.91 cfs and 950 acre-ft/yr was sold to T & R Farms by the previous property owner (see attachment 2: statutory warranty deed). This temporary trust donation application requests to donate 5,119 acre-ft/yr of DNR's 6,666 acre-ft/yr into the Trust water right program for the 2012 irrigation season. (Please see attachment 2: statutory warranty deed. Please advise, if purchase and sales agreement is needed as well.)

The 5,119 acre-ft/yr is available to donate to trust during 2012 irrigation season based on the incremental reduction in irrigated blocks of poplar trees during the 2012 season within the place of use. (see attachment 5: map showing fields irrigated at the end of the 2012 season, after all reductions.)



This conveyance includes any appurtenant water rights described in approved Water Right Change Application Nos. CS4-30634C(B) & CS3-22005C(B)@2 issued by the Department of Ecology, excluding that 950 acre foot portion of Certificate S3-22005C(B) described in the Water Right Purchase and Sale Agreement between T&R Farms, Inc. and Sandpiper Tree Farm, LLC, dated February 6, 2012, and effective as of March 2, 2012.

Grantor reserves the right to harvest the standing crop of poplar trees that are currently growing on the Property ("**Reserved Crop**"). Grantor shall pay all costs associated with the care and harvesting of Reserved Crop including but not limited to operation and maintenance of water system and roads. Grantor shall have a right of access over the real estate to harvest the Reserved Crop until the expiration of this reservation. This reservation expires eighteen (18) months after the date of this deed.


