One application each for portions of Certificates S4-01228C and SWC 9974--portions owned entirely by Wallula. It is also noted that approved changes apply to both Certificates also owned entirely by Wallula. ConAgra is leasing these rights from Wallula for the 2013-2014 irrigation seasons with the exception of 0.11 cfs and 16 af/yr from S4-01228C/change. Wallula is retaining these quantities to irrigate approx. 8 acres. ConAgra is filing these changes and seeking assistance from Ecology in pursuing the seasonal changes in the most expedient fashion that maximizes available rights.






Original Site Map


