6. Remarks and Other Relevant Information:

This water right change is part of the Roaring Creek Flow Restoration and Barrier Removal Project. The users of the only two diversions on the creek are seeking changes in points of diversion. The Upper Diversion (UD) users are seeking to move the point of diversion to a new location on the mainstem Entiat. The existing diversion with 7 water rights, plus the 6 water rights associated with the lower diversion (LD) divert 1.5 cfs, an amount greater than the base flow of Roaring Creek, an important stream for ESA listed steelhead rearing. Roaring Creek is within the Lower Entiat River Assessment Unit (RM 0.0-16.2) of the Entiat subbasin. The ESA listed salmonids that utilize the mainstem Entiat River within the Lower AU and project portion of the subbasin include endangered Upper Columbia River spring Chinook (*Oncorhynchus tshawytscha*), as well as endangered steelhead (*Oncorhynchus mykiss*) and threatened bull trout (*Salvelinus confluentus*). Non-listed salmonids such as summer Chinook and Coho, and resident fish species such as westslope cutthroat trout are also found here.

The primary goal of this change is to improve flow conditions in Roaring Creek for the benefit of steelhead rearing. The water would be transferred to trust for instream flow.

This project addresses limiting factors and implements actions recommended in the Entiat WRIA 46 Watershed Management Plan approved in 2004, the Entiat Subbasin Plan, and draft Upper Columbia Salmon Recovery Plan. Therefore, we request expedited processing under WAC 173-152-050(2)(b) and (3)(a).

Concurrent with this application, water right change applications are being filed to move the UD POD from Roaring Creek upper diversion to a new location on the Entiat River, at location beneath the old Roaring Creek bridge (~RM 5.9) on the Chelan County Right of way or beneath the new Roaring Creek bridge (~RM 6.0) and on the Chelan County right of way, and provide an irrigation well on property for the largest of two landowners on the LD.
