DESCRIPTION OF PROPOSED WORKS

This application seeks to consolidate points of diversion (POD) of these water rights to accommodate conversion to a sprinkler irrigation system for a portion of the place of use of these water rights. The water saved by the conversion to sprinkler irrigation will be donated to the Trust Water Rights Program for the life of the irrigation system (20 years).

The new POD location will be; 1 foot south and 100 feet ^{east} west from the ^{northwest} north quarter corner of Section 23, being within the N1/2 NW1/4 NW1/4 of Section, T. 17 N., R. 19 E.W.M. The new diversion will be two irrigation pumps connected to a NOAA compliant suction fish screen placed in Parke Creek near the Denmark Road bridge on the upstream side of the bridge. The pumps will supply water to a lateral move sprinkler and a center pivot sprinkler.

REPORT

BACKGROUND [See WAC 173-153-130(6)(a)]

On March 19, 2013 Dodge Family LLC of Ellensburg, WA filed an application for a change of point of diversion under CTCL 00191. The application was accepted at an open public meeting on March 19, 2013, and the board assigned application number KITT-13-01.

Attributes of the water right as currently documented

Name on certificate, claim, permit: Dodge Family LLC

Limitations of Use: The maximum that can be diverted under this water right and the right awarded to the claimants with the June 30, 1900 priority date is 3.5 cfs, as that is the maximum that can be diverted from the authorized point of diversion.

Point of diversion/withdrawal: 1 ft south and 1150 ft west from the north quarter corner of Section 23, being within the N½ NE¼ NW¼ of Section 23, T.17N., R.19E.W.M

Purpose of use: Irrigation of 72 acres and stock water

Period of use: March 15 through November 15

Place of use: NE¼ NE¼ of Section 22 and NW¼ NW¼ of Section 23 in T17N, R19 E.W.M.

Tentative determination of the water right

The tentative determination is provided on the front page of this report.

History of water use

Irrigation water and stock water has been diverted by using a gravity check structure from Parke Creek to irrigate the existing place of use since December 2, 1878. The irrigation water is used to rill irrigate a variety of hay, pasture, potatoes, sweet corn and other small grain crops.

Previous changes

There are no previous changes.

SEPA

The board has reviewed the proposed project in its entirety. This project is exempt from SEPA because it is only changing the point of diversion and place of use and it is under the cfs threshold. There is an existing Programmatic Exemption held by WDFW for pump fish screens.

INVESTIGATION [See WAC 173-153-130(6)(c)]

The following information was obtained from a site inspection conducted by Gregg Hall on April 26, 2013, technical reports, research of department records, and conversations with the applicant and/or other interested parties.

Proposed project plans and specifications

The Dodge Family LLC is working with the Kittitas County Conservation District (KCCD) to provide environmental benefit to Parke Creek by installing a NOAA compliant pump suction fish screen, remove fish passage barriers and provide saved water for instream flows in Parke Creek. Two other point of diversion changes for Dodge Family LLC are also part of this overall project.

The irrigation water will be used to irrigate hay, pasture, potatoes, sweet corn and other small grain crops with a lateral move sprinkler, a center pivot sprinkler and pvc gated pipe rill irrigation. The water will be diverted from Parke Creek using a NOAA compliant suction fish screen connected to two pumps feeding water to the sprinkler and gated pipe systems. Construction will begin as soon as the POD change is approved and will be completed by December 1, 2013. The new sprinkler system installation will provide saved water that will be donated to the Yakima River Basin Trust for instream flows for the anticipated life of the irrigation sprinkler system installed.

The new pump diversion will allow the KCCD to remove or modify three concrete structures on the Dodge property to benefit fish passage in Parke Creek

Other water rights appurtenant to the property (if applicable)

This property is also within the Ellensburg Water Company's (EWC) place of use and has EWC water.

Public Interest (groundwater only)

Does not apply.

Tentative Determination

In order to make a water right change decision, the Board must make a tentative determination on the validity and extent of the right. The Board has made the tentative determination as displayed upon the first page of this report. There are several circumstances that can cause the board's tentative determination to differ from the stated extent of the water right within water

right documentation. Water right documents attempt to define a maximum limitation to a water right, rather than the actual extent to which a water right has been developed and maintained through historic beneficial use. Additionally, except for a sufficient cause pursuant to RCW 90.14.140, water rights, in whole or in part, not put to a beneficial use for five consecutive years since 1967 may be subject to relinquishment under Chapter 90.14.130 through 90.14.180 RCW. Water rights may additionally be lost through abandonment. The Board's tentative determination was based upon the following findings: A site visit, aerial photos and irrigator/representative testimony indicates that the water has been used to the full extent of the water right.

Geologic, Hydrogeologic, or other scientific investigations (if applicable)

This is a downstream diversion change and there are no diversions between the old points of diversion and the new point of diversion. The Board concluded there were no other studies necessary.

Other

The new point of diversion on Parke Creek will be below the confluence of Sow Creek, which is a ditch/creek that captures significant return flow. Dodge Family LLC should not be allowed to benefit from the added water in Parke Creek that Sow Creek provides. Therefore, the Board imposed a limitation that prohibits diversion at the new point of diversion if water is not available at the historic points of diversion.

CONCLUSIONS [See WAC 173-153-130(6)(d)]

Tentative determination (validity and extent of the right)

The water right has been used to the full extent of 3.5 cfs and 432 acre feet as indicated by testimony, aerial photos and site visit.

DECISION [See WAC 173-153-130(6)(e)]

The Kittitas County Water Conservancy Board concludes that the POD change will not harm any other irrigators and is environmentally beneficial.

Conditions and limitations

Water may not be diverted at the new point of diversion if water is not available at the historic points of diversion.

The maximum that can be diverted under this water right and the right awarded to the claimants with the June 30, 1900 priority date is 3.5 cfs.

None necessary.

Construction Schedule

The construction will begin as soon as POD is approved (~ August 5, 2013) and should be completed by December 1, 2013.

1) Fish Screening

a. The intake at the new point of diversion shall be screened in accordance with Department of Fish and Wildlife screening criteria (pursuant to RCW 77.57.010, RCW 77.57.070, and RCW 77.57.040). 2) Water Metering


- a) An approved measuring device shall be installed and maintained for each of the sources identified by this water right in accordance with the rule "Requirements for Measuring and Reporting Water Use", WAC 173-173.
- b) Water use data shall be recorded weekly. The maximum rate of diversion/withdrawal and annual total volume shall be submitted to Ecology by January 31st of the following year.
- c) Department of Ecology personnel, upon presentation of proper credentials, must have access at reasonable times, to the records of water use that are kept to meet the above conditions, and to inspect at reasonable times any measuring device used to meet the above conditions.
- d) Recorded water use data shall be submitted via the Internet. To set up an Internet reporting account, contact the Ecology Central Regional Office in Yakima. If you do not have Internet access, you can still submit hard copies by contacting the Region Office for forms to submit your water use data.
