



A meeting of the Chelan County Water Conservancy Board was conducted in compliance with Chapter 42.30 RCW at 415 Washington Street, Wenatchee, Washington on June 10, 2010.

The board had previously issued a Record of Decision and Report of Examination on April 8, 2010 in the matter of Application for Change/Transfer No. CHEL-09-12, filed by Don West Family Properties LLC at the meeting mentioned above and by a majority vote, the board withdrew the referenced issued Record of Decision and Report of Examination for the following reason(s):

Accommodate the request of the Department of Ecology

The withdrawal of the referenced Record of Decision and Report of Examination is effective as of the adjournment of the meeting of the board during which it was adopted.
