This October 30, 1884 priority water right was exercised fully (4.0 cfs, 283.4 af/yr for irrigation of 26 acres and 2.5 af/yr for stock water, of water from the Yakima River, from April 1 through October 15 each year) by Schaaque Packing Company prior to its sale of the water right to the US Bureau of Reclamation in a sale that closed on August 6, 2003. This water right was confirmed in this quantity by the Yakima Adjudication Court's entry of the Conditional Final Order (CFO) for Subbasin No. 7 (Reecer Creek) on October 25, 2001. The Adjudication Court's June 14, 2007 Order Pendente Lite (OPL) transferred this water right to instream flow enhancement use in the Yakima River.
