Washington Water Trust is requesting a temporary donation of a portion of Court Claim No. 01863, Subbasin No. 3, to instream flow use on behalf of William and Carla Holmes from the date of the attached Order Pendente Lite (OPL) as approved by Yakima County Superior Court, June 11, 2009, (Attachment B) through April 30, 2012.

This Change Application seeks to effectuate a donation of the 2.38 acres served by the above referenced court claim to be used exclusively for instream flows for fish maintenance and enhancement, recreational uses and preservation of environmental and aesthetic values as allowed under RCW Chapters 90.03, 90.42 and 90.38. Water use changes associated with this application will provide significant environmental benefits to the Teanaway and Yakima Rivers, thus this transfer should receive expedited processing under WAC 173-152-050(2)(b) and (3)(a).

This application is accompanied by an Order Pedente Lite as ordered by the Yakima Superior Court on June 11, 2009 (Attachment B).


Washington Water Trust intends to protect this trust water right as instream flow in the Teanaway, Yakima, and Columbia Rivers.
