6. DESCRIPTION OF SYSTEM PROPOSED OR INSTALLED

Flow will be diverted from the Naches River at the new Oak Flats dam and fish screen. Gravity flow will be provided to the hatchery from the proposed irrigation system pipe line. The flow from the hatchery will be returned to the river at the site of the existing Natches-Selah headworks. The 4,400 foot diversion reach will be studied in 1991 to determine minimum instream flow requirements. Current hatchery requirements have been increased by 25%.
