7. THIS IS AN ONGOING DAIRY FARM, WITH 300 ANIMAL UNITS & 2 HOUSES CURRENTLY, WATER RIGHTS NEEDED FOR EXPANSION TO 700 ANIMAL UNITS, POSSIBLY 2 MORE HOUSES, 2 ACRES FARM LANDSCAPED GROUNDS.

IF 10 ACRE-FEET OR MORE OF WATER IS TO BE STORED AND/OR IF THE WATER DEPTH WILL BE 10 FEET OR MORE AT THE DEEPEST POINT, A STORAGE PERMIT MUST BE FILED IN ADDITION TO THIS PERMIT. THESE FORMS CAN BE SECURED, TOGETHER WITH INSTRUCTIONS, FROM THE DEPARTMENT OF ECOLOGY.


SECTION MAP

HWY 22




