PUMP AND MOTOR SIZE WILL DEPEND ON AVAILABLE WATER AND PUMPING HEAD. AN ESTIMATE MIGHT BE 1500 GPM VERTICAL TURBINE PUMP WITH A 200 HP, 3-PHASE ELECTRIC MOTOR.


