Publishing Legal Notice

- Select a newspaper with general circulation in the area the water will be used and diverted.
- Ensure that the notice appears once a week for two consecutive weeks.

If your published notice does not meet the above criteria, you will be required to have the notice republished at your expense.

Publication should start within 30 days from the date of this letter.

THE PLACE OF USE AS AUTHORIZED UNDER S4-29264C

TAKE NOTICE:

That on March 2, 2011, Mary Bailey of Brewster, WA, applied to change the point of diversion and to change the place of use as authorized under the above-referenced Certificate.

That said Certificate authorizes the irrigation of 3 acres, 0.49cfs and 15.9acre-feet of water, from the Columbia River from two points located within Government Lot 1 of Section 01, T. 29 N., R. 23 E.W.M., and Government Lot 3 of Section 36, T. 30 N., R. 23 E.W.M., Douglas County.

That said water is authorized for the purpose of irrigation and frost control within Government Lot 7 of Section 36, T. 30 N., R. 23 E.W.M., Douglas County.

That the applicant proposes to change the point of diversion authorized under S4-29264C to a point located within Government Lot 3 of Section 36, T. 30 N., R. 23 E.W.M., Douglas County.

That the applicant proposes to change the place of use authorized under S4-29264C to include lands within the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 1, T. 29 N., R. 23 E.W.M., and the N $\frac{1}{2}$ NW $\frac{1}{4}$ and the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 6, T. 29 N., R. 24 E.W.M.; and the SW $\frac{1}{4}$ and the W $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 31, T. 30 N., R. 24 E.W.M., all in Douglas County.
