6. Remarks and Other Relevant Information:

The Columbia View Water System (CVWS) owns three wells which are used to provide domestic and irrigation water to approximately 121 residential lots located in the Columbia View Addition. The existing wells are relatively shallow (approximately 80' deep) and have nitrate levels close to 30 ppm. The water does not meet the Washington State Department of Health (WSDOH) clean drinking water standards.

In 2008 CVWS and the Port of Walla Walla (Port) signed an agreement that allows the Port to provide domestic water to CVWS from their Nitrate Treatment Plant located in Burbank, Washington. The domestic water supplied by the Port meets the Washington State Department of Health (WSDOH) clean drinking water standards.

CVWS is currently constructing a new distribution system from the Ports Nitrate Treatment Plant to the personal property line of each customer. Construction should be complete by November of 2009.

The new distribution system and the existing wells will be used to meet the needs of the CVWS customers.

CVWS requests that the Ports Burbank Well be added as a point of diversion or Withdrawal under the water rights of CVWS as indicated in Section 4B of this document.

It is requested that the DOE expedite this process.
