On September 15, 2011 our office received your applications for water right permits and has assigned them the numbers shown above. Please include these numbers if you contact us regarding these applications.

The minimum application fee is \$50.00 for each application (\$100.00 total) which is now due.

This is based on your request for:

- 11.33 gallons per minute (0.03 cubic feet per second);
- 17.00025 gallons per minute (0.04 cubic feet per second).

There might be other aspects of the applications that need additional follow-up that I will address at a later date when I have sufficient time to review the applications. I tried to contact you at 509-633-9441 x. 130; but your voice mail was not set up. In the meantime, please confirm the rates for the proposals are 11.33 gpm/0.03 cfs and 17.00025 gpm/0.04 cfs. No action will be taken on the applications until the fees are paid in full. The applications will be rejected if the additional fees are not submitted within 60 days of this notice.
